4. Contents of the published information:

The interim financial statements prepared on 12 August 2026 recorded a variance of more than 10% in profit compared with the same period in 2025, and the Company's profit after tax for the first half of 2026 changed from a profit to a loss compared with the corresponding period of 2025. The Company would like to provide the following explanations:

The Company's accumulated profit after tax for the first six months of 2026 was a loss of VND 3.17 billion, representing a decrease of VND 3.48 billion compared with the same period in 2025, and changing from a profit of VND 315 million in the first six months of 2025 to a loss of VND 3.17 billion in the first six months of 2026. The change was mainly attributable to the following reasons:

- Net revenue from sales of goods and rendering of services for the first six months of 2026 amounted to VND 86.1 billion, representing a decrease of VND 14.11 billion, or 14.08%, compared with the same period of the previous year.

- Gross profit from sales of goods and rendering of services for the first six months of 2026 amounted to VND 9.15 billion, representing a decrease of VND 1.43 billion, or 13.48%, compared with the same period of the previous year.

- Selling expenses for the first six months of 2026 amounted to VND 8.9 billion, representing an increase of VND 1.12 billion, or 14.36%, compared with the same period of the previous year.

As a result, the Company recorded an accumulated loss after tax of VND 3.17 billion for the first six months of 2026, representing a decrease of VND 3.48 billion, or 1,104%, compared with the same period in 2025, and changing from a profit of VND 315 million in the first six months of 2025 to a loss of VND 3.17 billion in the first six months of 2026.
